To be produced during loan application

- ❖ Proof of land ownership or permit to cultivate the land: Title deed/ lease agreement
- ❖ National ID
- ❖ If cultivating group land, written agreement of representative members of group will be required.
- ❖ If cultivating trust land, details of land owner and relationship to farmer will be required.

To be attached with the form

- ✓ Copy of the title deed or lease agreement
- ✓ Copy of farmers national ID
- ✓ Passport sized photo of the farmer in charge of production

**NOTE:** *These documents will be kept safe and in **confidentiality** for every member of WVCI in their file and will be used during the considerations for the applied agrarian seasonal loan viability and approval.*
